STANDARD OPERATING PROCEDURE (SOP) FOR CANDIDATE

LL.M. (Master of Laws) ADMISSIONS-2026

1. The Candidates have to carry original documents for verification alongwith one set of self attested copies of the following documents and visit **Hall No. 1, Indian Law Institute, New Delhi.**
 - Marksheets & Certificates (10th, 12th and Graduation Degree)
 - Marksheets and Certificates of LL.B.
 - Migration Certificate
 - Copy of SC, ST, OBC (NCL), PwD, EWS, Kashmiri Domicile/ Migrant Certificate (*The Certificate should be valid as on the date of admission*)
 - Passport size photograph
 - One cancelled cheque of candidate's bank account
 - Declaration format duly filled in as provided with this SOP.
 - Aadhar Card
2. Candidates have to make sure that they are eligible for admission to the Course. Any candidate found ineligible at any point of time during study his/ her admission will be summarily rejected. The admission shall stand cancelled if student is unable to produce the original document within the admissible time as per rules.
3. The details of the fees as mentioned in the **Prospectus - 2026** at page no. 39 will be as below:

The last date and time for physical verification of documents and submission of fee is the **Thursday, 30th July, 2026 (4.00 p.m.) for Third Merit List. The candidates are hereby informed that the admission process will be conducted from Monday to Friday only. Saturday and Sunday will be Holidays.**

Note : The candidates are required to deposit the Admission Fee (ONLINE) only after their candidature are verified and found in order, to avoid any ambiguity and problem in refund (Admission Fee) thereof.

4. After successful payment, screenshot of the payment must be e-mailed to academic@ili.ac.in
5. **The candidates appearing for the minimum eligibility examinations are required to submit their certificate positively on or before September 15, 2026.**
6. **In case of failure of submission of required certificate(s)/ documents for fulfilling eligibility criteria, the admission will be cancelled.**
7. **Those candidates who could not produce latest original OBC-NCL Certificate at the time of *viva*, are mandatorily required to submit the same at the time of admission if they have been selected. Otherwise their admission will be cancelled and the seats will be allocated to next OBC-NCL Category candidate from the merit list.**
